

**PUNCH CIGARS - THE GREAT AMERICAN BEER FESTIVAL® TRIP GIVEAWAY  
OFFICIAL RULES**

**THE SWEEPSTAKES IS INTENDED FOR PARTICIPATION IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA (“D.C.”) ONLY, EXCLUDING MASSACHUSETTS, MICHIGAN, AND VIRGINIA. YOU MAY NOT ENTER UNLESS YOU ARE TWENTY-ONE (21) YEARS OF AGE OR OLDER AND A LEGAL RESIDENT OF AND LOCATED IN ONE OF THE ELIGIBLE STATES OR D.C., AND WERE A SMOKER PRIOR TO LEARNING OF THE SWEEPSTAKES. **1. PROMOTION PERIOD:** The Punch Cigars - The Great American Beer Festival® Trip Giveaway (the “Sweepstakes”) begins at 10:00 AM Eastern Time (“ET”) on June 1, 2026, and ends at 10:00 AM ET on August 3, 2026 (the “Promotion Period”).

**2. SPONSOR:** Forged Cigar Company, Inc., 2100 E. Cary Street, Suite 200. Richmond, VA 23223 (“Sponsor”).

**3. ELIGIBILITY:** The Sweepstakes is only open to individuals who: (a) are twenty-one (21) years of age or older at the date of entry; (b) are a legal resident of (and residing at the time of entry in) one of the 50 United States or D.C. (excluding Massachusetts, Michigan, and Virginia); and (c) were a smoker prior to learning of the Sweepstakes. The following individuals are NOT eligible to enter or win a prize: employees, officers and directors of Sponsor and its parent companies, subsidiaries, divisions, affiliates, advertising/promotion/judging agencies, and any other entities affiliated with the administration of the Sweepstakes, and the immediate family members (parent, child, sibling, spouse) of each such person, and persons living in the same household as each such person (whether related or not). Sponsor’s determinations of eligibility are final and may be made at any time. The Sweepstakes is: (i) void outside the 50 United States and D.C.; and (ii) void in Massachusetts, Michigan, Virginia, and wherever prohibited.

**4. AGREEMENT TO TERMS:** Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to and acceptance of the terms of these Official Rules and the decisions and interpretations of the Sponsor and its designees, which are final and binding in all respects. Winning a prize is contingent upon fulfilling all requirements set forth herein. Any entrant may be disqualified in Sponsor’s sole discretion if they fail to comply with any of the terms of these Official Rules.

**5. Sponsor’s computer is the official time-keeping device for the Sweepstakes. **Limit one (1) entry per person/email address, per Eastern Time calendar day of the Sweepstakes.**

Sponsor reserves the right to verify the age/identity of any entrant through third party Veratad Technologies, LLC; entrants that do not pass this verification process (if applied) will be disqualified, all as determined by Sponsor in its sole discretion. Entries become the property of Sponsor and may not be acknowledged or returned. Multiple entrants are not permitted to share the same email address. Entries are void if late, unreadable, inaccurate, incomplete, tampered with, forged, mechanically reproduced, irregular in any way or otherwise not in compliance with these Official Rules. Entries submitted in excess of stated limits will be void. Use of any automated system to enter is prohibited and will result in disqualification at Sponsor’s sole discretion. Any attempt by any entrant to obtain more than the stated maximum number of entries by using multiple/different accounts, identities, registrations, or logins, or through any other methods, may void all of that entrant’s entries and that entrant may be disqualified. Sponsor is under no obligation to correspond about entries, nor is Sponsor required to acknowledge its receipt of entries. Sponsor reserves the right to, and at its sole discretion may, reject any entry for failure to comply with any applicable entry requirements. Proof of submission of entry does not constitute proof of receipt of entry. In the event of a dispute as to the identity of the entrant associated with any entry, the authorized account holder of the email address associated with the entry, at time of submission, will be

deemed to be the entrant. The “authorized account holder” is the natural person assigned to the email account by the applicable email account provider. Potential winner may be required to show proof of being the authorized account holder. In the event a dispute regarding the identity of the person who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. Normal Internet access and usage charges imposed by your online service will apply. If you participate from your mobile phone, such activity will be subject to the charges pursuant to your wireless service provider's rate plan. You further agree that by providing your mobile phone as part of your participation information, you are consenting to Sponsor or its designee contacting you via a live call or text message to your mobile phone if you are a potential winner, which will be subject to the charges pursuant to your wireless service provider's rate plan.

**6. RANDOM DRAWING/PRIZE DESCRIPTION/ODDS:** On or about August 6, 2026, an independent judging organization will conduct a random drawing from among all eligible entries received to select one (1) potential Grand Prize winner. The verified Grand Prize winner will receive a four (4) night trip for winner and one (1) guest (age 21+) to Denver, Colorado including: round trip coach air travel to the Denver, Colorado area for winner and one (1) guest (age 21+) from the major gateway airport closest to winner's residence (airports determined solely by Sponsor); double occupancy hotel accommodations for four (4) nights at a hotel selected by Sponsor; admission for winner and one (1) guest (age 21+) to the Punch & Untappd Kick-off party on Friday, October 9, 2026; admission for winner and one (1) guest (age 21+) to The Great American Beer Festival® on Saturday, October 10, 2026 and Sunday, October 11, 2026; one (1) \$250 rideshare service gift card/code selected by Sponsor; \$500 in prepaid gift cards selected by Sponsor, intended for winner and guest to use for certain meals; and a package of Punch Cigar swag selected by Sponsor. The total approximate retail value of the Grand Prize is \$3,840. Actual value of prize may vary depending on point of departure and fare/rate fluctuations. **Trip must be taken on dates selected by Sponsor in its sole discretion, currently anticipated to be departing on October 8, 2026, and returning on October 12, 2026, but subject to change as deemed necessary in Sponsor's sole discretion, or trip will be forfeited in its entirety.** All travel arrangements must be made through the Sponsor or Sponsor's designee. Use of any event admission ticket is subject to terms printed/referenced on the ticket. Certain other restrictions may apply. Winner must travel on the same itinerary as their guest. It is the responsibility of winner and their guest to provide proper travel documentation (including government issued “Real ID” picture identification and/or passport, as required). Airline tickets are non-refundable/non-transferable and are not valid for upgrades and/or frequent flyer miles. All airline tickets are subject to flight variation, work stoppages, and schedule or route changes. Sponsor reserves the right to structure travel route and select accommodations in its sole and absolute discretion. A winner will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules. The round-trip air transportation element for the prize begins and ends at the point of departure. The Grand Prize is subject to seat and accommodation availability, as well as Sponsor's terms and conditions generally applicable thereto. For the avoidance of doubt, round trip coach air travel is limited to one plane seat per traveler. Released Parties (as defined in Section 8 below) shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers or any other persons providing any prize-related services or accommodations. Any prize details not specified will be determined by Sponsor in its sole discretion.

A potential winner will be notified at the email address provided at the time of entry, by Sponsor or Sponsor's designee. Any such email notification will instruct the potential winner to reply as specified within seventy-two hours after the time that the notification email was sent. A potential winner must reply as instructed to confirm their eligibility and ability to accept the prize and provide their complete contact information within such seventy-two-hour period, or they will be disqualified. In Sponsor's sole discretion, a potential winner may further be required to complete and return a declaration of eligibility, a liability release, a publicity release (where legal), and provide a copy of a valid government-issued identification card as proof of age and identity, all of which must be returned within the time period specified by Sponsor at the time of such request. the applicable eligible, non-suspect entries received up to the time of such cancellation, termination, modification or suspension, as applicable, or to proceed in such a manner as may be deemed fair and equitable by Sponsor in its sole discretion.

Entry must be made by the entrant and via the means described in these Official Rules. You are not a winner until your entry has been verified and you have complied with these Official Rules. If any provision of these Official Rules is found to be invalid or unenforceable by a court of competent jurisdiction, such provision will be severed from the remainder of these Official Rules, which will otherwise remain in full force and effect. Sponsor's failure to enforce any portion of these Official Rules does not affect or waive Sponsor's right to enforce any portion of Official Rules at any time. When terms such as "may" are used in the Official Rules, Sponsor has sole and absolute discretion. Entrants agree to waive any rights to claim ambiguity of these Official Rules.

Entrants further understand and agree that all rights under Section 1542 of the Civil Code of California ("Section 1542") and any similar law of any state or territory of the United States that may be applicable with respect to the foregoing release are hereby expressly and forever waived. Participants acknowledge that Section 1542 provides that: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY." The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future or unknown claims.

**10. CONDUCT:** By participating in the Sweepstakes, entrants: (i) represent and warrant that all information provided by entrant in connection with the Sweepstakes is true, accurate and complete; and (ii) agree to comply with all federal, state and local laws and regulations. Sponsor reserves the right, at any time and at its sole discretion, to disqualify and/or deem ineligible to participate in the Sweepstakes or any future Sponsor promotions, any individual it suspects: (a) to be tampering with the entry process or the operation of the Sweepstakes or any website; (b) to be acting in violation of these Official Rules or Sponsor's privacy policy or other applicable terms, conditions or guidelines; (c) to be acting in bad faith or in a disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person; (d) to have failed to agree to these Official Rules; or (e) to be in violation of these Official Rules.

PUBLICITY:** By participating, you grant to Sponsor and its affiliated companies the right, except where prohibited by law, to use your name, likeness, picture, address (city and state), voice, biographical information, and written or oral statements about the Sweepstakes or Sponsor's products/services (the "Materials"), for advertising and promotional purposes in promoting or publicizing Sponsor, its affiliated companies, and the products or services of each, in any and all media without limitation as to time or territory, without compensation unless required by law.
